## Construction Types Subject to Review:

- Mixed construction, tilt-up (1976 or newer) and metal
- Older buildings ok based on excess attachment point
- Excess of tuck-under values
- Exclude flood zone A & V on primary accounts
- No poor soil conditions (very high liquefaction/soft soil)

- Excel spreadsheet statement of values:
  - City, state, zip
  - Construction, occupancy, year built
  - Square footage of building, number of stories & buildings
  - Breakdown of values
- Insured business description/operations
- Effective date

- Term requested
- Quote due date
- Limits, perils, coverage's & deductibles required
- Current layering & premiums
- Suggested layering
- Target pricing & TIV breakdown
- Loss history & and inspections or engineering reports
